Restatement of Marine Insurance Law

Another decision taken by EXCO in Rio was following an idea put to EXCO by past Vice President Dieter Schwampe. Dieter proposed the creation of an IWG on the Restatement of Marine Insurance Law and Practice." EXCO approved this new IWG and we could not think of a better Chair than Dieter for this new IWG.

The IWG has already started to work in earnest and I am circulating with this letter a letter by Dieter to all the NMLAs with a request that you provide the IWG with texts of statutory marine insurance law as well as standard marine insurance terms in respect of hull and machinery as well as cargo insurance, generally used in your jurisdictions.

May I kindly ask that you provide Dieter with this information up until the 30th of November.

Ratification of conventions – UN Annual Treaty Event 22nd – 25th September 2026

A number of you will recall that the United Nations holds an Annual Treaty Event to coincide with the holding of the General Assembly of the United Nations during which countries are encouraged to deposit their instruments of ratification with regard to those UN Conventions where the Secretary General of the United Nations is identified as the Depository. We would like to invite you to view the UN web page containing information on the event:

Last year the CMI and the ICS published a joint brochure on the “Promoting Maritime Treaty Ratification of International Maritime Conventions promoting the ratification of international maritime conventions - <https://comitemaritime.org/work/maritime-conventions/>.

There are of course a number of conventions which require ratification however it will not surprise you if I were to underline the importance of reminding you to remind your governments about the need to ratify the *Convention on the International Effects of Judicial Sale of Ships* which as you are fully aware came into force in February of this year with the EU adopting it in June of this year. We are fully aware of the fact that a number of EU Member states are now working on their internal domestic laws to enable their jurisdictions to accommodate the Convention and to enable them to ratify the Convention.

Let us continue to make this Convention a great success by securing more ratifications.

Standing committee on the ratification of the Rotterdam Rules and the Convention on Negotiable Cargo Documents.

On my own behalf and on behalf of EXCO and the whole of the CMI I would like to thank Past President Stuart Hetherington for the time, dedication and determination with which he chaired the standing committee on the ratification of the Rotterdam Rules, which later also incorporated the Convention on Negotiable Cargo Documents. Stuart informed us in Rio that he wished to stand down from being the chair and regrettably my efforts at trying to convince him to stay on were not successful. A big thank you to Stuart from all of us for chairing this standing committee and steering it through all its ups and downs with such passion and drive. I am however very happy to announce that we have identified the ideal successor to Stuart, and that is Jose Angelo Estrella Faria whose recent past makes him the perfect chair for this standing committee.
